PERSON SPECIFICATION

Our Trustee must have:

- Integrity
- Commitment to the organisation and its objectives
- An understanding and acceptance of the legal duties, responsibilities, and liabilities of a trusteeship
- A willingness to devote the necessary time and effort to their duties as a trustee
- Strategic vision
- Good, independent judgement
- An ability to think creatively
- Willingness to speak their mind
- An ability to work effectively as a member of a team.

The Trustee Board will need skills and experience in some or all of the following areas:

- Setting targets, monitoring and evaluating performance and programmes in commercial and non-profit organisation
- Financial management
- The type of work being done by the organisation
- Legal matters
- Fundraising
- Recruitment and personnel management, including a knowledge of employment legislation
- Public relations.

DUTIES & RESPONSIBILITIES

1. Ensure the charity is carrying out its purposes for the public benefit – you and your co-trustees must make sure that the charity is carrying out the purposes for which it is set up, and no other purpose. This means you should:

- a. Ensure you understand the charity's purpose as set out in its governing document
- b. Plan together what The Fund will do, and what you want it to achieve
- c. Be able to explain how all of the charity's activities are intended to further or support its purpose – including how the charity benefits the public by carrying out its activity.

2. Comply with your charity's governing document and the law – you and your co-trustees must:

- a. Make sure that the charity complies with its governing document
- b. Comply with the charity law requirements and other laws that apply to your charity
- c. Take reasonable steps to find out about the legal requirements, for example by reading relevant guidance or taking appropriate advice when you need to.

3. Act in your charity's best interests – you must:

- a. Enable the charity to carry out its purposes
- b. With your co-Trustees, make balanced and adequately informed decisions, thinking about the long term as well as the short term
- c. Avoid putting yourself in a position where your duty to your charity conflicts with your personal interests or loyalty to any other person or body
- d. Not receive any benefit from the charity unless it is properly authorised and is clearly in the charity's interests; this also includes anyone who is financially connected to you, such as a partner, dependent child or business partner.

DUTIES & RESPONSIBILITIES

4. Manage your charity's resources responsibly - act responsibly, reasonably and honestly - referred to as the 'duty of prudence'

- a. Make sure the charity's assets are only used to support or carry out its purposes
- b. Consider appropriate procedures and safeguards and take reasonable steps to ensure that these are followed
- c. Avoid exposing the charity's assets, beneficiaries or reputation to undue risk
- d. Not over-commit the charity
- e. Take special care when investing or borrowing.

5. Act with reasonable care and skill - as someone with shared responsibility for governing the charity you must:

- a. Use reasonable care and skill, making use of your skills and experience and taking appropriate advice when necessary
- b. Give enough time, thought and energy to your role, for example by preparing for, attending and actively participating in all Trustees' meetings.

6. Ensure your charity is accountable - use reasonable care and skill, making use of your skills and experience and taking appropriate advice when necessary

- a. You and your co-Trustees must comply with statutory accounting and reporting requirements
- b. Be able to demonstrate that your charity is complying with the law, is well run and effective.
- c. Ensure accountability within the charity, particularly where you delegate responsibility for particular tasks or decisions to staff or volunteers.
